Effective Tuesday, March 24, 2020 at 8 a.m. the Sandusky County Clerk of Courts offices will be as follows:

Sandusky County Clerk of Courts - 100 North Park Ave., Ste. 208, Fremont, OH 43420

- The office will be closed to the public for in person service, but the office will remain staffed. Staff will continue to answer the phones and process filings. Paperwork for filing may be submitted by fax (419-334-6164), via mail, or by dropping off at the drop box located at the Courthouse entrance by Security. Payments may be submitted by phone, mail, or online on the website www.sandusky-county.org/clerk. Please contact 419-334-6161 with any questions that you may have concerning the office.
- Anyone that needs to file a Civil Protection Order or Stalking Protection Order should contact the Prosecutor's Victim Advocate for an appointment at 419-334-6418.


- The office will be closed to the public, but continue to be staffed for any inquiries or assistance. If you have any questions, please feel free to contact that office at 419-334-6243.
